

## Aquatic Plants Information Sheet What to Do and Who to Contact

- 1. Indigenous Aquatic Plants
  - a. Report unusually dense mats of aquatic plants at <a href="http://waterrangers.ca/en">http://waterrangers.ca/en</a> and to OLLA Aquatic Plants Sub-Committee via <a href="mailto:postmaster@otterlake.org">postmaster@otterlake.org</a>
  - b. Removal of excessive indigenous aquatic plants directly in front of your property must be done in compliance with the Public Lands Act and Regulations and under the authority of the Ontario Ministry of Natural Resources & Forestry (MNRF).

3. Algal Blooms

Report all algae blooms, except suspected blue-green algae blooms, at <a href="http://www.waterrangers.ca/en/">http://www.waterrangers.ca/en/</a> as well as the OLLA Aquatic Plants Sub-Committee via <a href="mailto:postmaster@otterlake.org">postmaster@otterlake.org</a>

- 4. Blue-Green Algae Blooms
  - Report all suspected blue-green algae blooms to the Ontario Ministry of the Environment and Climate Change Spills Action Centre at 1-800-268-6060 and advise the OLLA Aquatic Plants Sub-Committee via <u>postmaster@otterlake.org</u> Note: The <u>RVCA is not involved</u> with blue-green algae blooms.
  - b. Assume all blue-green blooms to be toxic and avoid exposure to humans and animals. Consider an alternate drinking water supply if you get your water from the lake; boiling the water does not remove these toxins. Call the Health Unit at 1-800-660-5853 for more information.

## TIP: Take pictures of any reported algae blooms or unusual aquatic plants and take note of where they were observed.
