Annual General Meeting – Saturday, July 27th, 2019

OLLA's AGM took place on Saturday, July 27th at the South Elmsley Hall. There were approximately 60 people in attendance. The financial and membership reports were accepted and the Lake Steward's report was presented. A short update on the Lake Plan was provided followed by a brief synopsis and discussion of the JP2G Otter Lake Outlet Investigation Report, with Mayor Arie Hoogenboom providing comments on next steps.

An election by secret ballot was held to fill five vacancies on the Board of Directors. Seven members stood for election with the following being elected for three-year terms: Judy Hodgins (Road O12); Susan Thum (Road O10); Dianne Taylor (Road 06), John McKenney (Road 05A) and Jeff Neal (Road 07).
