Loon Nest Platforms – Looking For Volunteers

We are looking for volunteers to build two loon nest platforms over the winter months. The nests will be built with PVC piping and chicken wire (supplied by OLLA). In the early spring the nests will be covered with native vegetation and placed in locations that are favourable for loon pairs to build their nests for successful hatching of chick(s). The floating nest platforms will be anchored with cinder blocks and chains allowing the loons to have continued access to their nests regardless of any fluctuation in spring water levels. This initiative is in response to only one chick being successfully reared on Otter Lake this

OLLA's Invasive Phragmites Project Completed!

In February 2021 FOCA (Federation of Ontario Cottagers Association) reached out to Ontario Lake associations offering the opportunity to apply for grants to combat Invasive Phragmites.

Invasive Phragmites have become Ontario's worst invasive species. They aggressively invade wetland habitats out competing native species and transform habitats into dense monocultures that are inhospitable to most wetland inhabitants.

Unfortunately, the applications for grants had to be made before the end of February 2021. As the ice was still on our lake, OLLA was unable to get boats out to survey the lake's shorelines. However, we did detect several large stands – one on the Old Kingston Road just north of Otter Lake Road and several on Highway 15. Not knowing if we had a problem ON Otter Lake or not, we applied for a grant to educate our lake landowners about Invasive Phragmites. FOCA allowed us a \$400.00 education grant.

The good news – once the ice went out and the OLLA Board of Directors could get boats in the water, a survey of Otter Lake's shoreline revealed no stands of this invasive plant. However, we proceeded with the educational component of the project.

OLLA designed and created signage for the 5 commercial establishments on the lake – Camp Otterdale, Moonlight Bay, Otter Lake Park, Sandy Beach at Otter Lake and Twin Pines Campgrounds. Thanks to all the campground owners who enthusiastically posted the signage for us. A sign was also created and posted on the OLLA bulletin board at the boat launch.

Information about Invasive Phragmites was published in the OLLA Newsletter and on the OLLA website (have you checked out our new website? www.otterlake.org).

FOCA provided warning signs (do not cut or transplant) to post at the large stand on Old Kingston

Road. Unfortunately, we were unable to post these signs at the stands on Highway 15 due to MTO regulations.

325 information brochures were printed to distribute to all Otter Lake Landowners. Thanks to the Township of Rideau Lakes for the assistance in mailing these.

And finally, we submitted our post program questionnaire to FOCA and returned \$41.04 to FOCA as we came in under budget!

We hope to be invited to join any future FOCA programs that can benefit our lake.

Lake Trout Spawning Ground Review

Past OLLA Director, Karl Fiander, is continuing to be the lead on OLLA's project to identify spawning areas for Lake Trout and to establish that Otter Lake has the necessary oxygen levels to support Lake Trout with the goal of a stocking program to rebuild the population. Attempts to get the Ministry of Natural Resources & Forestry (MNRF) to conduct field work to help in determining whether Otter Lake can sustain Lake Trout has been hindered because of Covid protocols. Karl also reached out to Dr. Steven Cooke, a professor at Carleton University, who advised at the start of the summer he had a PhD student who could possibly come to survey our lake.

On October 7th Karl escorted Ben Hlina on a tour of the lake on Jeff Neal's boat. Several areas were identified as having the necessary characteristics for Lake Trout spawning as well as areas that are well suited for this fish species to feed and thrive. Some of the potential spawning grounds are around the northern-most islands and the shoal area opposite Sandy Beach Resort. Lake Trout spawn in the evening during the fall and hatch under the ice in January. At this time it is felt the native strain of Lake Trout that evolved in Otter Lake since the ice age, is all but gone and any remaining fish would likely be from the "Algonquin" strain that is stocked by MNRF.

Karl will be submitting a written report to OLLA to support our lobbying for an MNRF stocking program. Together with Ben's survey findings, the deep water oxygen levels recently reported by the Rideau Valley Conservation Authority (RVCA) appear to be adequate for Lake Trout survival. The next step will be to submit the report to MNRF with a formal request for Otter Lake to be restocked with Lake Trout.

Trailered Boats Now Regulated

For a number of years, using newsletters, boat ramp signage and other methods, OLLA has been reminding members and others about the importance of ensuring boats are drained, cleaned and dried before moving from one body of water to another. In this past year trailered boats have become regulated under the Invasive Species Act. The Ministry of Northern Development, Mines, Natural Resources and Forestry finalized amendments to Ontario Regulation 354/16 under the Invasive Species Act, 2015 to regulate watercraft as a carrier of invasive species. (The changes also classify 13 species as either prohibited or restricted invasive species.). The rules are based on the Clean, Drain, Dry practices which have been promoted through education and outreach efforts across North America, by FOCA, and others. Highlights of the change effective January 1, 2022:

- boaters are now required to remove drain plugs, drain all on board water and remove any aquatic plants upon removing the watercraft from a waterbody, and
- prior to reaching a launch site for a body of water, the watercraft, watercraft equipment and any vehicle or trailer used to transport the watercraft or watercraft equipment must not have an aquatic plant, animal or algae attached to it.

Note: watercraft includes any motorboat, rowboat, canoe, punt, sailboat, or raft. For further details about this change see:
